Westside Home Inspections Pool Inspection Agreement

The address of the property is: 11828 Horley Avenue Downey, CA 90241

Fee for the inspection is \$250. Fee is due at commencement of inspection.

at 2:00 (Time).

This agreement is made on 5/31/2022 (Today's Date) between Jose L. Barrera (hereinafter "INSPECTOR") and the undersigned ("CLIENT"), collectively referred to herein as "the parties." The Parties understand and voluntarily agree as follows:

- Purpose:** The intention of the Swimming- pool/spa inspection is to evaluate the whole pool environment including the current condition of all accessible pool components, identify items that need repair to make the pool operational, safe, and reasonable to maintain. It will also identify the condition of the fence, gates, walkway, pool perimeter, slide, diving board, deck, rails, coping, lighting, structure, and other items of possible concern. Occasionally the inspection will reveal that further specialized testing is warranted.
- Scope:** The scope of the Swimming-pool/Spa Inspection is limited to those areas which are above ground or water level and are readily accessible during the time of the inspection. The report is based on the condition of the property at the precise time and date of the inspection. The whole pool environment will be generally evaluated but the report is not technically exhaustive; pool filtering devices are not disassembled to determine the condition of any installed filter elements. Operation of time clock motors and thermostatic temperature controls cannot be verified during a visual inspection. Pilot lights on LP gas pool heaters are not lit during the inspection. Underground leaks in a supply line, buried pipe fitting, or pool surface cracks are detected by observation of the persistent and continuous loss of water from the pool over an extended period of time and is beyond the scope of the inspection Water Testing: Unless specifically noted above water testing is beyond the scope of the inspection.
- Report:** The CLIENT will be provided with a written report of the INSPECTOR's visual observations and if water testing is noted as included in this report the results of the chemical analysis of any samples collected will be included. Optional water testing includes testing for the following items: Free Chlorine, Total Chlorine, Bromine, pH, Alkalinity, Calcium Hardness, and Cyanuric Acid. The report is not intended to comply with any legal obligations to disclosure.
- Standards of Practice:** Unless otherwise inconsistent with this Agreement or not possible, INSPECTOR agrees to perform the inspection in accordance with the current Standards of Practice for Performing Pool Inspections of the

International Association of Certified Home Inspectors ("InterNACHI") posted at <http://www.nachi.org/sop.htm>.

Although INSPECTOR agrees to follow InterNACHI's Standards of Practice, CLIENT understands that these standards contain limitations, exceptions, and exclusions. CLIENT understands that InterNACHI is not a party to this Agreement and has no control over INSPECTOR or representations made by INSPECTOR and does not supervise INSPECTOR.

5. **Exclusivity:** The report is intended for the sole, confidential and exclusive use and benefit of the CLIENT and the INSPECTOR has no obligation or duty to any other party. INSPECTOR accepts no responsibility for use by third parties. There are no third party beneficiaries to this agreement. This agreement is not transferable or assignable. Notwithstanding the foregoing, the CLIENT understands that the INSPECTOR may notify the homeowner, occupant, or appropriate public agency of any condition(s) discovered that may pose a safety or health concern.

6. **Limitation of Liability:** INSPECTOR assumes no liability for the cost of repair or replacement of unreported defects or deficiencies either current or arising in the future. CLIENT acknowledges that the liability of INSPECTOR, its agents and/or employees, for claims or damages, costs of defense or suit, attorney's fees and expenses arising out of or related to the INSPECTOR'S negligence or breach of any obligation under this Agreement, including errors and omissions in the inspection or the report, shall be limited to liquidated damages in an amount equal to the fee paid to the INSPECTOR, and this liability shall be exclusive. CLIENT waives any claim for consequential, exemplary, special or incidental damages or for the loss of the use of the home/building even if the CLIENT has been advised of the possibility of such damages. The parties acknowledge that the liquidated damages are not intended as a penalty but are intended (i) to reflect the fact that actual damages may be difficult and impractical to ascertain; (ii) to allocate risk among the INSPECTOR and CLIENT; and (iii) to enable the INSPECTOR to perform the inspection at the stated fee.

7. **Dispute Resolution; Binding Arbitration:** Any dispute, controversy, interpretation or claim including claims for, but not limited to, breach of contract, any form of negligence, fraud or misrepresentation arising out of, from or related to this contract or arising out of, from or related to the inspection and inspection report shall be submitted for final and binding arbitration under the Rules and procedures of the American Arbitration Association. **CLIENT agrees to pay all required filing fees.** The decision of the Arbitrator appointed thereunder shall be final and binding and judgment on the Award may be entered in any court of competent jurisdiction."

8. **No Rule Of Construction:** The parties acknowledge that each of them has had ample opportunity for their own counsel to participate in negotiating and drafting this Agreement. Therefore, no rule of construction shall apply to this Agreement that construes ambiguous or unclear language in favor of or against any party."

9. **Attorneys Fees:** In the event of litigation relating to the subject matter of this Agreement, the non-prevailing party shall reimburse the prevailing party for all reasonable attorney fees and costs resulting therefrom."

10. **Severability:** If any court having jurisdiction declares any provision of this Agreement to be invalid or unenforceable, the remaining provisions will remain in effect.

11. **Payment:** Payment of the fee to INSPECTOR (less any deposit noted above) is due upon completion of the on-site inspection. The CLIENT agrees to pay all legal and time expenses incurred in collecting due payments, including attorney's fees, if any. If CLIENT is a corporation, LLC, or similar entity, the person signing this Agreement on behalf of such entity does personally guaranty payment of the fee by the entity.

12. **Limitations Period:** Any legal action arising out of this Agreement or its subject matter must be commenced within one year from the date of the Inspection or it shall be forever barred. The CLIENT understands that this limitation period may be shorter than the statute of limitations that would otherwise apply.

13. **Entire Agreement:** This Agreement represents the entire agreement between the parties. All prior communications are merged into this Agreement, and there are no terms or conditions other than those set forth herein. No statement or promise of INSPECTOR or its agents shall be binding unless reduced to writing and signed by INSPECTOR. No change shall be enforceable against any party unless it is in writing and signed by the parties. This Agreement shall be binding upon and enforceable by the parties and their heirs, executors, administrators, successors and assignees. CLIENT shall have no cause of action against INSPECTOR after one year from the date of the inspection.
